

# A Checklist of What to Do After Someone Passes Away:

Ten important things to do after someone passes away and one thing to avoid.

#### **1. APPROVE ORGAN DONATION.**

This is time sensitive. Notify the hospital immediately if this was something the deceased wanted.

#### 2. SEE THAT ANY DEPENDENTS AND/OR PETS ARE CARED FOR.

- Children
- Dependent Adults
- Pets

#### 3. NOTIFY CLOSEST FAMILY, FRIENDS, AND CLERGY.

- The American Red Cross can help locate people in the military.
- Contact a grief counselor if one is needed.

#### 4. LOCATE IMPORTANT PAPERS.

- Look for a will or trust in a file cabinet, personal safe, or safe deposit box.
- Look for instructions for funeral, burial, or cremation.
- □ Look for passwords for accounts and digital platforms.

#### 5. REMEMBER TO REMINISCE.

- Take time to look at photos, tell stories, and let others tell theirs.
- You might start a journal to capture your thoughts and feelings.

#### 6. CONTACT THE ATTORNEY AND EXECUTOR OF THE ESTATE.

- Notify all power of attorney agents and trustees of the death.
- Ask if they know some of the deceased last wishes.

# A Checklist, continued...

## 7. BEFORE VISITING THE FUNERAL HOME, DETERMINE IF BENEFITS ARE AVAILABLE.

Benefits may be available if the deceased was a member of certain organizations, in the military, or on public assistance.

If the death was due to Covid-19, see if you qualify for FEMA help.

### 8. VISIT THE MORTUARY TO MAKE PLANS FOR FUNERAL, BURIAL, CREAMATION, AND/OR END-OF-LIFE SERVICE.

- Invite someone supportive and practical to go with you.
- Prepare an obituary and schedule it.
- Consider a charity that people can donate to in lieu of flowers.

#### 9. PROTECT, MANAGE, AND MAINTAIN THE PROPERTY.

- This includes a house, vehicle, business, furnishings, etc.
- Take photos of valuables (guns, jewelry, collections, etc.) and secure them.
- Make sure the mail is collected and newspapers picked up.
- Have someone stay in the house during the funeral service.
- ☐ If you're the Executor for the estate, consider changing the locks.

#### 10. CONTACT EMPLOYERS, EXTENDED FAMILY, AND FRIENDS.

- Do this within a day or two of death. Benefits may be available.
- □ Notify extended family members and friends.

### **\*\*\*DO NOT** ALLOW THINGS TO BE TAKEN FROM THE ESTATE UNTIL YOU HAVE PERMISSION. AND DON'T LET OTHERS TAKE THINGS EITHER.**\*\*\***

This could affect the assets of the estate and have tax implications.
